### **Minutes**

LDLT: Common problems and opportunities; how the group functions; any recommendations to improve. The LDLT Member of the month will put together the agenda and run the meeting.

#### **How LDLT works**

- The meetings are more productive than last year
- Being aware of what's going on in other units is very useful
- Getting others perspectives helps
- Make sure there is enough time for updates and announcements
  - o This sparks discussion
- Combination of updates and discussion of bigger issues and strategic direction
- PSEC vs. LDLT
  - Overlap of what PSEC and LDLT needs to do (next AUL can give direction on that)
  - o What is the difference?
    - PSEC deals with the nitty gritty issues of operating Public Services (e.g. in Access Services) unless it needs to come up to LDLT
    - LDLT members are responsible for the success of many of the committee plans, so are important players in the process
    - Mary is the liaison from LDLT to PSEC Instruction and Bonna is the c-chair of PSEC and the PSEC liaison to Access Services
  - o Do we need PSEC and LDLT?
    - LDLT does not include Special Collections
    - Special Collections would be a big take on by AUL
    - Could have a representative from RMC work with AUL
    - Restructured PSEC helpful to keep informed about what's going on with RMC. for instance
      - How does that information get out to the broader group
- Colleen Cuddy wasn't involved with LDLT previously; however, would it be a good idea to involve her?

- Yes, but would this group, being Ithaca-centric, not be useful to her?
- Anne will be conducting monthly calls with Colleen
  - She will be involving her with MC
- Mary's involving her in Life Sciences
- What hasn't worked so well with LDLT?
  - The group has made changes as they go, one issue is running out of time with too many items on the agenda
  - People come as 'resource communication people' when the group has already seen the information elsewhere
- Where are we with Strategic Plan?
  - Documented and shared with units (also posted on Wiki)
  - Some have been more aligned with CUL priorities
- While Anne is here:
  - o address immediate concerns and get to know LDLT
  - Unified Budget Model and fall out from that
    - Strategies with dealing with it, specifically Mann
  - August/September ask Lee to come talk to the group about key elements/issues in discussions
  - Anne met with Bob Buhrman regarding the Federal Mandate related to Data and Published Articles
    - Issues in terms of how this roles out (Oya and Wendy)
    - ILR's outside funding
      - Federal, Department of Labor, Health & Human Services, Disabilities (from Labor, Foundations/Non-profit)
- What are LDLT Expectations?
  - o Updates from LEG and Managers' Council Meetings
  - Having a representative from this group at LEG Meetings
  - Knowing what's going on with the University and how they connect with us
  - o Anne's impression of what's going on
  - A hotline to Anne while making a difficult decision feel free to call or email Anne and/or appropriate contact in LEG

- Difficult to get people to come to Cornell everyone's trying to get them

Will Public Services reinvestment positions be announced at All Staff? – Anne, YES. (Look on All Staff notes)

Re Dean's small group convened to look at automating some tasks, we need good people but we don't need them doing repetitive tasks

### **Updates from PSEC - Bonna**

- Common call for Committees
  - Trying to avoid each committee issuing multiple calls on CU-LIB, and present opportunities in a single announcement
  - How to tweak Qualtrics form to share info
  - HR will send the announcement(s) in the future, since the call included groups outside PSEC's purview
  - Bonna is the liaison to the Steering Committee
  - LSC would like to have a town meeting before fall (Gail is the liaison to PSEC)
    - When should this happen, where, and agenda/funding?

Anne had coffee with new staff, she enjoyed seeing the excitement and pride for Cornell in them.

### Kornelia - Information System Updates - Aries

- Worried Aries updates will be coming in the beginning of the semester (new updates going live at the beginning of the semester is troublesome)
- The reserve system is of concern
- Anne Looking for interim Lead for Discovery and Access (Janet & Dean were coleads)
  - Release pilot "Black light" any advice for interim lead?
  - A good person may be Maureen Morris (Steve)
  - o Bonna would consider, if necessary

### Updates from ALA, especially the BD Policy Group – Kornelia

### **BD Policy Group**

- In August, University of Chicago 'soft launch' of joining BD
  - Will only be open to a handful of people for six weeks at 50% load leveling (at full service)
- Track shipment time for six weeks; see if we can achieve the four-day turnaround (use UPS)
  - May use air to ship items but not to return
- Everyone's meeting a four-day turnaround with current partners
- We are fast processing requests, however, shipping is slow due to our location
  - It takes the same amount of time for us to ship to Harvard as it is for MIT to ship to Harvard
  - We are at 3.6 days turnaround
- Chicago has opened up all formats and would like us to as well
  - o DVDs/CDs/Microforms
  - We are not currently including microforms in BD
  - o DVDs: BD cannot set up different loan periods for DVDs
  - The Policy group will investigate who is willing to open what under what conditions
    - Medium rare requests are only available in RMC, so are not in BD
    - If they are circulating, then they are in BD
- John Hopkins is joining BD next year
- Duke is not sure when they are going to join
- Contract with software company needs to be updated
  - The Policy group will sign a two-year contract rather than three-year
- Operations and Systems Meeting in the Fall
- General Philosophy of BD?

- Anne IVY plus Group the bigger ones are not the lenders ironically it's the smaller ones
- Having more libraries involved means more availability of items
- Went to PS Head Meeting Just the panel (Angie will send Anne the document that Janet sent to LDLT)
  - No discussion of anything that would concern us

## Shared security patrol possibility for 24/7 spaces - Curtis

Management Library & Catherwood 1st floor open 24/7 in the fall (via card access)

- o Mann will open 24/7 access in the fall as well
  - o To help avoid propping doors, anyone with a Cornell ID will have access
  - Lobby/CIT Computer Lab
- o Maybe possible to use the same security form as the rest of the libraries
  - Olin Library Security guards working 24/5
    - Would never have a non-monitored space
  - Engineering library doesn't have security guards
  - 24/7 access is depending on this
    - Just ease of mind
  - Mann installed security cameras as a deterrent
    - Police said they would Make a trip through Mann Library periodically during shifts
    - Night managers schedules will bump back to overlap with day schedule because 24/7 allows them to close two hours early
- People want access earlier on Saturday mornings
  - Want access to collections.

#### **Announcements and Updates**

We have had questions about who is responsible for physical facilities for the FAL in Rand; Lee and Phil will be meeting with their AAP counterparts to clarify expectations

- o Whose responsibility is it?
  - o Lee said same people just different Library accounts

 Anything attached (carpets etc.) is schools responsibility/Furniture is library

\*\*Discussion for Lee in August/September CALS is clearing second floor

- Have homes need to get them there
- o Fourth floor goes to department

Second floor opens up – redesigned for group and individual study rooms

 Hopefully by mid-semester seating capacity will be the same or greater than before
