**OPERATING PROJECTION**

Table 1 includes an operating projection for 2012-2017 including four key sources of revenues: Cornell’s annual funding of \$75,000 per year and indirect expenses, \$50,000 per year gift from the Simons Foundation, annual fee income from the member institutions, and a \$300,000 per year challenge grant from the Simons Foundation based on the revenues generated through membership payments.

The annual membership fees reflected in Table 1 factor in an average annual increase of 2%. To further encourage participation in the arXiv membership program, the fees would decrease as the number of participating institutions increases. The weighted average fee, taking into account the number of participating institutions at each fee level, would be \$2,374 in 2013. Cornell’s goal is to raise \$300,000 per year through the membership fees generated by approximately 126 institutions. This financial strategy will allow building a contingency fund to support unforeseen expenses and ensure a sound business model.<sup>1</sup>

<sup>1</sup> Currently, arXiv has a contingency fund of approximately \$125,000 accumulated during the last two years due to unexpected staff vacancies and other savings, such as transition to virtual servers. Guidelines for the use of these funds will be discussed with the Member Advisory Board.
