4.5. Day 1:

4.5.1. DNA extraction / template preparation using the Qiagen DNeasy Blood & Tissue Kit

NOTE: If using the Archive Pure DNA extraction procedure, see Appendix PNL32-1. A minimum of 4 - 6 hours must be allocated to complete the process.

4.5.1.1. **Before beginning this procedure, first:**

- 4.5.1.1.1. Pre-heat water bath or heat block to $56^{\circ}C \pm 1$.
- 4.5.1.1.2. Check DNeasy kit reagents and dilute where necessary (i.e. ethanol needs to be added to both wash buffers prior to the very first use).
- 4.5.1.1.3. Prepare the elution buffer, 10 mM Tris HCl pH 8.0, as follows:
 - 4.5.1.1.3.1. Add 10 ml of 1 M Tris-HCl, pH 8.0 to 990 ml molecular grade water. Invert several times to mix (store at $2 8^{\circ}$ C).
- 4.5.1.1.4. For Gram positive DNA extractions: Prepare the enzymatic lysis buffer (ELB):20 mM Tris, 2 mM EDTA, 1.2 % Triton:

5 ml 1 M Tris-HCl, pH 8.0 1 ml 0.5 M EDTA 3 ml Triton X-100

- Bring the volume up to 250 ml with molecular-grade water and
 - mix gently to incorporate Triton (this may be done with a stir bar and stir plate).

NOTE: The 250 ml stock of enzymatic lysis buffer will last for 1 year at room temperature $(15 - 30^{\circ}C)$.

4.5.1.2. Cell lysis of Gram positive organisms:

4.5.1.2.1. Label one spin column and two 1.5 ml microcentrifuge tubes for each isolate, and prepare two additional collection tubes per sample.

NOTE: Only one 1.5 ml microcentrifuge tube for each isolate is required at this point.

4.5.1.2.2. Add 20 mg/ml of lysozyme to appropriate amount of the lysis buffer within 24 hours of use. For example, for 18 isolates: 3420 μl ELB + 68.4 mg lysozyme

4.5.1.2.3. Dispense 180 μl of prepared ELB-lysozyme mixture to each labeled 1.5 ml microcentrifuge tube.

NOTE: Thoroughly mix to ensure the lysozyme is fully incorporated before dispensing.

4.5.1.2.4. Fill a 1 μ l inoculating loop with overnight growth (see image below) and add to the 180 μ l ELB-lysozyme mixture in the 1.5 ml microcentrifuge tube. Vortex for approximately 5 – 10 seconds.



- 4.5.1.2.5. Incubate at 56 ± 1°C for 30 min.
 NOTE: Vortexing every 10 minutes throughout the incubation process will facilitate and improve cell lysis.
- 4.5.1.2.6. Add 4 μ l of RNase A solution and vortex at medium speed (e.g. speed '7' on a Daigger Vortex Genie) for 5 10 seconds.

- 4.5.2.2.11. The value for the 260/280 field (i.e. protein content) should be between 1.75 and 2.05 (this includes a 0.05 error rate). 4.6. Day 1 or 2:

NOTE: Sample Plate and Sample Sheet setup steps in the Experiment Manager program on the Illumina MiSeq can be completed at any point in this protocol, but must be performed prior to the start of the run. When sequencing less than 7 samples or for newly trained laboratory personnel, we recommend creating the Sample Plate and Sample Sheet at the beginning of the library prep. Refer to Appendix PNL32-3 for detailed instructions on how to complete these steps.

4.6.1. Library Prep

4.6.1.1. Enter the 260/280 Nanodrop values, the Genome Size Estimate and the DNA concentrations determined from the Qubit BR dsDNA Assay Kit (Section 4.5.2.1) into the appropriate columns on the Initial Dilution tab of the Nextera XT Library Prep Workbook (Appendix PNL32-4).


NOTE1: When preparing to set up a run, consider the total DNA load allowance for the reagent kit to be used prior to selecting the number of isolates. The <u>DNA load</u> (sum of Mb for all isolates) for a 500 cycle cartridge is ~80 Mb, and ~60 Mb for a 300 cycle cartridge. For example, for a 500 cycle cartridge, 16 isolates with a 5 Mb genome could be prepped for a total DNA load of 80 Mb. Alternatively, 8 isolates with a 5 Mb genome, 11 isolates with a 3 Mb genome, and 4 isolates with a 1.6 Mb genome could also be run with the 500 cycle kit.

NOTE2: The genome size estimates for *E. coli*, *Salmonella*, *Campylobacter*, *Listeria*, *Vibrio cholerae*, and other *Vibrio spp*. are as follows: *E. coli* and *Salmonella* – 5 million bases (or megabases, Mb); *Campylobacter* – 1.6 million bases; *Listeria* – 3 million bases; *Vibrio cholerae* – 5 million bases; other *Vibrio spp*. – 4.5 million bases.

NOTE: Tagmentation and PCR setup should be performed in a clean space separate from all other post-PCR processes in order to reduce the possibility of cross-contamination.

Indices are color balanced in pairs 701/702, 703/704, and 705/706 for index 1, as well as 503/504 and 505/506 for index 2. When choosing indices for a run, ensure there is a set of at least one color balanced index pair per sequencing run (e.g. 701/503, 701/504, 702/503, 702/504). See Illumina's technical note for examples of "good" and "bad" color balanced pairs:

4.6.1.7.3. It is also <u>important to rotate through the indices from run to run</u> <u>to prevent read carryover</u>. The same index pairs <u>should not be</u> <u>used within 6 consecutive runs</u> on the same sequencer so as to reduce the amount of carryover generated during the run, which can interfere with downstream analyses. The following table illustrates a suggested index rotation scheme. This index rotation can also be utilized in the Nextera XT Library Prep Workbook by selecting the preferred run option from the dropdown menu above the Index 1/2 columns.

4.6.2. Setting up a run on the MiSeq

NOTE1: At least 100 GB disk space (20% of the hard drive) will be needed before a run can be started. It is also important to reboot the MiSeq at least once a week (and recommended after deleting large amounts of data) as a part of routine maintenance of the machine. This will clear the virtual memory ensuring that the memory capacity for future runs is at a maximum.

NOTE2: The cartridge takes approximately 1 hour to thaw in a water bath at room temperature and once thawed can be stored on ice or at $2 - 8^{\circ}C$ for up to 24 hours (see Appendix PNL32-6 for instructions). Alternatively, the cartridge can be thawed in its original packaging at $2 - 8^{\circ}C$ (8-12 hours), and then stored at $2 - 8^{\circ}C$ for up to 7 days. If thawing using this procedure, proceed directly to step 4.6.2.2.

4.6.3. Day 2 or 3

4.6.3.1. Exporting Data from the MiSeq

- 4.6.3.1.1. Record run statistics (i.e. Q30, cluster density, clusters passing filter, estimated yield) in the table on the worksheet after the run has finished and before proceeding to the post-run wash.
- 4.6.3.1.2. Data is found in the D drive \rightarrow Illumina \rightarrow MiSeqOutput \rightarrow Run folder (choose the most recent run folder) \rightarrow Data \rightarrow Intensities \rightarrow BaseCalls. Within the BaseCalls folder the raw read data is in fastq.gz format, there will be 2 files per isolate for paired reads. This data can be copied onto an external hard drive or USB drive with sufficient space and moved to a computer workstation. Please note that it takes 20 minutes to 1 hour for the MiSeq to generate data post run. For Basespace users, the data will be located in the run folder on Basespace.

NOTE: If fastq data is unavailable for a given isolate(s) due to incorrect index assignment or sample sheet error, the run can be requeued for analysis using either MiSeq Reporter (MSR) or corrective options in BaseSpace (see Appendix PNL32-9).

4.6.3.2. Post-Run Wash and Reagent Disposal

- 4.6.3.2.1. Once the run is complete, select the Start Wash option at the bottom right-hand side of the screen.

4.6.3.6. Management of Disk Space on D: (Data) Drive of Illumina MiSeq

- 4.6.3.6.1. The MiSeq requires 100GB of disk space free on the D drive before sequencing on the MiSeq can start. Data should be cleared from the D drive after washing the MiSeq and data transfer of fastq.gz files is complete and assuming no troubleshooting is necessary for that run.

DNA Extraction / template preparation using the 5Prime ArchivePure DNA Cell/Tissue Kit

1. Procedure

1.1. Day 1

1.1.1. Streak an isolated colony from test cultures to TSA-SB plate (or comparable media). Incubate cultures at $37^{\circ}C \pm 1$ for 16 - 24 hours.

1.2. Day 2

1.2.1. Inoculate Trypticase Soy Broth.

NOTE: Culture from a plate can be used as well (see image below step 4.5.1.2.4. for suggested amount of starting culture). If using culture from a plate, continue to step 1.3.1.4.

1.3. Day 3

1.3.1. Cell lysis for Gram negative bacteria

- 1.3.1.1. Add 1.5ml of cell suspension (overnight culture) to a 1.5ml centrifuge tube.
- 1.3.1.2. Centrifuge at 14,000 x g (11,000 rpm) for 5 seconds to pellet cells.
- 1.3.1.3. Remove the excess broth leaving approximately 50 µl.
- 1.3.1.4. Add 300 µl Cell Lysis Solution to the remaining solution and pipette up and down until the cells are re-suspended.

NOTE: If using culture from a plate of overnight growth, add the loopful directly to the $300 \ \mu$ l Cell Lysis Solution and vortex for 5-10s.

- 1.3.1.5. Incubate at $80^{\circ}C \pm 1$ for 10 minutes.
- 1.3.1.6. Add 1.5 µl RNase A Solution (4 mg/ml) to the cell lysate.
- 1.3.1.7. Mix the sample by inverting the tube 25 times and incubate at $37^{\circ}C \pm 1$ for 1-2 hours.

1.3.2. Cell lysis for Gram positive bacteria

- 1.3.2.1. Add 1.5ml of cell suspension (overnight culture) to a 1.5ml centrifuge tube.
- 1.3.2.2. Centrifuge at 14,000 x g (11,000 rpm) for 5 seconds to pellet cells.
- 1.3.2.3. Remove the excess broth leaving approximately 50 µl.
- 1.3.2.4. Add 300µl Cell Suspension Solution and pipette up and down until the cells are suspended.
 NOTE: If using culture from a plate of overnight growth, add the loopful directly to the 300µl Cell Lysis Solution and vortex for 5-10 seconds.
- 1.3.2.5. Add 1.5µl Lytic Enzyme Solution and invert tube 25 times to mix.
- 1.3.2.6. Incubate sample at $37^{\circ}C \pm 1$ for 30 minutes to digest cell walls.
 - **NOTE:** Inverting the samples occasionally during the incubation will facilitate and improve the lysis.
- 1.3.2.7. Centrifuge at $13,000 16,000 \times g (10,000 11,500 \text{ rpm})$ for 1 minute to pellet the cells. Remove the supernatant.
- 1.3.2.8. Add 300µl Cell Lysis Solution to the cell pellet and gently pipette up and down to lyse the cells.
- 1.3.2.9. Incubate at $80^{\circ}C \pm 1$ for 10 minutes.
- 1.3.2.10. Add 1.5µl RNase A Solution (4 mg/ml) to the cell lysate.

1.3.2.11. Mix the sample by inverting the tube 25 times and incubate at $37^{\circ}C \pm 1$ for 1-2 hours.

1.3.3. Protein precipitation

- 1.3.3.1. Cool the sample to room temperature by placing on ice for 1 minute.
- 1.3.3.2. Add 100µl Protein Precipitation Solution to the cell lysate.
- 1.3.3.3. Vortex vigorously at high speed for 20 seconds to mix the Protein Precipitation Solution uniformly with the cell lysate (should form a white solution).
- 1.3.3.4. Incubate on ice for 10 minutes.
- 1.3.3.5. Centrifuge at 14,000 x g (11,000 rpm) for 4 minutes. The precipitated proteins will form a tight pellet.
- 1.3.3.6. Transfer the supernatant containing the DNA (leaving behind the precipitated protein pellet) to a clean 1.5ml microfuge tube. Do not disturb the pellet!
- 1.3.3.7. Incubate on ice 5 minutes.
- 1.3.3.8. Centrifuge at 14,000 x g for 4 minutes.

1.3.4. DNA Precipitation

- 1.3.4.1. Pipette the supernatant containing the DNA into a clean 1.5 ml microfuge tube containing 300 μl of 100% Isopropanol (2-propanol).
- 1.3.4.2. Mix the sample by inverting gently 50 times.
- 1.3.4.3. Centrifuge at 14,000 x g (11,000 rpm) for 1 minute. The DNA pellet should be visible as a small white pellet.
- 1.3.4.4. Pour off the supernatant (Pellet may be loose so pour slowly and so as not to disturb the pellet) and add 300 µl 70% Ethanol (Optional: invert the tube several times to wash the DNA).
- 1.3.4.5. Centrifuge at 14,000 x g for 1 minute. Carefully pour off the ethanol. Pellet may be loose so pour slowly so as not to disturb the pellet.
- 1.3.4.6. Briefly spin down the tube again to bring the remaining ethanol to the bottom of the tube. Remove the remaining ethanol using a 100 µl pipette.
- 1.3.4.7. Allow the tube(s) to air dry for 10 15 minutes.

1.3.5. DNA hydration

1.3.5.1. Add 100 µl of 10 mM Tris-HCl pH 8.0, pipette up and down to remove DNA from the wall of the tube or dislodge the pellet. Keep in mind that the DNA may form a diffuse pellet along the tube wall.

OPTIONAL: An aliquot of 10 mM Tris-HCl can be warmed briefly (approx. 1-2 minutes) in a $65^{\circ}C \pm 1$ water bath.

NOTE: A 10 mM stock of Tris-HCl pH 8.0 can be obtained by adding 10 ml of 1M stock Tris-HCl to 900 ml of molecular grade water. All stocks of Tris-HCl should be stored at $2 - 8^{\circ}$ C.

1.3.5.2. Rehydrate the DNA by incubating the sample(s) for 1 - 1.5 hours at $65^{\circ}C \pm 1$.

OPTIONAL: Pulse spin briefly to collect sample at the bottom of the tube.

NOTE: Samples can be left overnight at room temperature to facilitate rehydration. For long-term storage, keep DNA extracts at -15° C to -80° C.

DNA Clean & Concentrator-5 Kit Procedure

1. Before starting:

- **1.1.** For the 25 prep kit: Add 24 ml 100% ethanol (26 ml 95% ethanol) to the 6 ml DNA Wash Buffer concentrate.
- **1.2.** For the 100 prep kit: Add 96 ml 100% ethanol (104 ml 95% ethanol) to the 24 ml DNA Wash Buffer concentrate.

2. Procedure:

NOTE: All centrifugation steps should be performed between $10,000 - 16,000 \times g (9,000 - 11,500 \text{ rpm})$.

2.1. In a 1.5 ml microcentrifuge tube, add 2-5 volumes of ChIP DNA Binding Buffer to each volume of DNA sample1 (see table below). Mix thoroughly.

- 2.2. Transfer this mixture to a provided Zymo-Spin Column¹ in a collection tube.
- 2.3. Centrifuge for 30 seconds and discard the flow-through.
- 2.4. Add 200 µl DNA Wash Buffer to the column. Centrifuge for 1 minute and repeat the wash step.
- 2.5. Add 20 μl of 10 mM Tris-HCl pH 8.0 directly to the column matrix (do not touch the filter with the pipette tip).
- 2.6. Incubate at room temperature for one minute.
- 2.7. Transfer the column to a 1.5 ml microcentrifuge tube and centrifuge for 30 seconds to elute the DNA.
- 2.8. Repeat steps 2.5 2.7 eluting into the same microcentrifuge to obtain a final DNA sample volume of 40 μ l.
- 2.9. The DNA is now ready for library preparation.

¹The sample capacity of the column is 800 μ l. It may be necessary to load and spin a column multiple times if a sample has a volume larger than 800 μ l.

Thawing and Storing Thawed MiSeq cartridges

1. Overnight thawing method (preferred)

- 1.1. Remove cartridge from freezer and place at 2 8 °C in original packaging.
- 1.2. Just before use, invert the cartridge several times and gently tap it on the bench to mix and reduce air bubbles in the reagents.

NOTE: The cartridge can be kept thawed for up to seven days at 2 - 8°C, though it is recommended to use the thawed cartridge within 24 hours.

NOTE2: Once the cartridge is thawed it <u>cannot</u> be refrozen.

2. Rapid thawing method

2.1. Place the reagent cartridge in a large ice bucket containing enough room temperature deionized water to submerge the base of the reagent cartridge up to the water fill line printed on the reagent cartridge.

NOTE: Do not allow the water to exceed the maximum water line or allow the top of the cartridge to get wet.

2.2. Allow the reagent cartridge to thaw in the room temperature water bath until completely thawed.
 NOTE: Water can be changed every 15 – 20 minutes to expedite thawing. The cartridge takes approximately 1 hour to thaw at room temperature and once thawed can be stored on ice or at 2 – 8 °C for up to 24 hours.

NOTE: Once the cartridge is thawed it <u>cannot</u> be refrozen.

3. Just before use, invert the cartridge several times and gently tap it on the bench to mix and reduce air bubbles in the reagents.

Addition of PhiX Control

1. Procedure

NOTE: If using a previously prepared PhiX denatured dilution, proceed to Step 8.

- 1.1. Combine the following volumes to dilute the PhiX library to 2 nM:
 - 1.1.1. 10 nM PhiX library (1 μl)
 - 1.1.2. EBT (4 µl)
- 1.2. Add 400 ml of molecular-grade water to a 100 µl aliquot of 1 N NaOH to obtain a 0.2 N solution.
- 1.3. Combine the following volumes of 2 nM PhiX library and 0.2 N NaOH in a microcentrifuge tube to result in a 1 nM PhiX library:
 - 1.3.1. 2 nM PhiX library (5 µl)
 - 1.3.2. 0.2 N NaOH (5 µl)
- 1.4. Discard the remaining dilution of 0.2 N NaOH.
- 1.5. Vortex briefly to mix the 1 nM PhiX library solution.
- 1.6. Centrifuge the PhiX solution briefly at 200-280 x g.
- 1.7. Incubate for 5 minutes at room temperature to denature the PhiX library into single strands.
- 1.8. TIME SENSITIVE: Add the following volume of pre-chilled HT1 to the tube containing denatured PhiX library to result in a 20 pM PhiX library:
 - 1.8.1. Denatured PhiX library (10 µl)
 - 1.8.2. Pre-chilled HT1 (490 µl)
- 1.9. Label, date and initial the microcentrifuge tube. Denatured 20 pM PhiX libraries may be stored up to three weeks at -15° to -25°C.
- 1.10. Dilute the denatured 20 pM PhiX library to 8 pM as follows:
 - 1.10.1. 20 pM denatured PhiX library (40 µl)
 - 1.10.2. Pre-chilled HT1 (60 µl)
- 1.11. Determine percentage PhiX (N%) to add to run. If troubleshooting a library preparation, the 1-10% is appropriate, if troubleshooting a MiSeq instrument issue, then 5% or above (also depending on Illumina tech support guidance) is appropriate. If using PhiX routinely in every run, then 1% is recommended.
- 1.12. Combine N x 10μl of 8 pM PhiX with 1000 (N x 10) μl of the diluted denatured 10 pM sample library.
 - 1.12.1. For example, for a 1% PhiX addition, add 10 µl of 8 pM PhiX to 990 µl of denatured 10 pM sample library.
- 1.13. Set PhiX-spiked pooled library aside on ice until you are ready to load it onto the MiSeq reagent cartridge.


Performing a Maintenance Bleach Wash

- 1. When performing a weekly post-run bleach (Sodium hypochlorite) wash prepare a fresh dilution of bleach solution using molecular grade water and sodium hypochlorite (there are several options for bleach solutions with varying percentages of chlorine, see the appropriate dilutions for 4%, 6%, and 8.25% below). Bleach may be used for specific applications to reduce carry-over of nucleic acid from previous runs.
 - 1.1. Refer to the table below to make the serially diluted bleach solutions. The second dilution (0.01%) should be made in a MiSeq wash tube/wash reservoir (Figure 1, Item A).

NOTE: Contact Illumina Tech Support for information on obtaining wash tubes. **NOTE2:** A fresh dilution of bleach should be prepared before each wash.

- 1.2. Perform this wash as weekly maintenance by accessing the Post-run Wash option from the Illumina MiSeq home screen > Perform Wash or as the post-run wash following a sequencing run.
 - 1.2.1. In the following screen select the Perform Post-Run Wash option, and then select Start Wash on the next screen.
 - 1.2.2. Open the reagent compartment door and then chiller door to access the wash tray.
 - 1.2.3. Remove the wash tray and empty the left over wash solution (0.5% Tween 20) into the sink.
 - 1.2.4. Insert the wash tube into position 17 in the wash tray until the neck is flush with the tray (Figure
 - 1, Item B), and fill the remaining reservoirs with 0.5% Tween 20 wash solution.

- 1.2.5. Slide the wash cartridge into the reagent chiller until it stops and close the reagent chiller door.
- 1.2.6. Make sure to select the box to "Perform optional template line wash".
- 1.2.7. In the reagent compartment, raise the sipper handle, remove the PR2 bottle and replace with the MiSeq wash bottle containing 0.5% Tween 20.
- 1.2.8. Remove the liquid waste receptacle and dispose of contents in the formamide waste bottle.
 - **1.2.8.1.** NOTE: All liquid that accumulates in the MiSeq waste bottle should be disposed of as formamide waste, including liquid from wash cycles. All formamide waste bottles must be clearly labeled with contents, date of first use, and date of final use. Waste must be stored in designated, clearly labeled waste disposal site.
- 1.2.9. Return the liquid waste receptacle to the reagent compartment, lower the sipper arm, and close the reagent compartment door.
- 1.2.10. Select Next to begin the wash.
- 1.2.11. Once the 20 minute Post-run wash is complete, select "Done" on the screen to return to the MiSeq Control software home screen.
 - 1.2.11.1. **OPTIONAL:** A post-run wash with 0.5% Tween 20 wash solution should be performed directly following the post-run bleach wash to ensure all bleach is removed from the template line.
 - 1.2.11.2. To perform a post-run wash following a bleach wash:
 - 1.2.11.2.1. From the home screen select Perform Wash > Perform Post-Run Wash.
 - 1.2.11.2.2. Select Start Wash.
 - 1.2.11.2.3. Remove the wash tray from the reagent chiller and the wash tube from Position 17.
 - 1.2.11.2.4. Refill all reservoirs, including Position 17, in the tray with 0.5% Tween 20 wash solution.
 - 1.2.11.2.5. Raise the sipper arm and remove the waste receptacle. Dispose of the contents in the waste bottle, return the waste receptacle to the reagent compartment, and lower the sipper arm.
 - 1.2.11.2.6. Select Next to begin the wash.
 - 1.2.11.2.7. Once the wash is complete, the flow cell, wash bottle, and liquid waste receptacle should remain in place until the next sequencing run is to be performed.

Requeueing a Run for Analysis

There are detailed instructions on how to requeue analyses from the MiSeq Reporter (MSR) interface and in BaseSpace in the respective software guides:

1. **Procedure**

1.1. Requeue a run Using MiSeq Reporter

- 1.1.1. In order to apply the corrected or new analysis parameters to a run, a new sample sheet must first be created. To select a run to be re-queued with a new sample sheet, it is important that the input files are present in the analysis run folder. SampleSheet.csv, RTAComplete.txt, and RunInfo.xml must all be present.
- 1.1.2. In the analysis run folder (D:Illumina/MiSeq Analysis/"Recent run") delete the "QueueForAnalysis.txt" file.
- 1.1.3. Rename the old sample sheet (for example, "SampleSheet.csv.old") and paste the newly revised sample sheet in the analysis folder under the name "SampleSheet.csv".
 - 1.1.3.1. If correcting index assignment, the new sample sheet should have the corrected index pair assignments and corresponding index sequences.
- 1.1.4. Connect to MiSeq Reporter on the local computer by opening Internet Explorer. If MiSeq Reporter does not open with the launch of Internet Explorer, type in the search bar: http://localhost:8042/
- 1.1.5. Check the checkbox next to the run and Click "Requeue". The reanalysis will take roughly an hour.

NOTE: MiSeq Reporter requires the following files which are generated during the sequencing run to perform secondary analysis or to requeue analysis: all *.bcl, *.filter, and *.locs.

1.1.6. The reanalyzed data (i.e. fastq files) will be stored in the "Basecalls" folder of the run analysis and output folders.

1.2. Fix Sample Sheet / Re-Run Workflow in BaseSpace

NOTE: In order to requeue the analysis within BaseSpace, you must be the owner of the run. Additionally, <u>a corrected sample sheet and requeued run can only be submitted one time</u>.

1.2.1. The Fix Sample Sheet page can be reached in one of two ways:

- 1.2.1.1. If the run is in a "Needs Attention" state, then the run can be opened and the Fix Sample Sheet option selected.
- 1.2.1.2. Or you can navigate to a run, select the More drop-down list, and select Fix Sample Sheet.
- 1.2.2. Once the **Fix Sample Sheet** page opens, any errors BaseSpace has detected should be shown above the black sample sheet editor.
- 1.2.3. There are two options depending on the complexity of the change:
 - 1) The easier fix is editing the sample sheet in the Sample Sheet Editor. BaseSpace will validate the sample in real-time as you edit.
 - 2) The more complex option is using the Illumina Experiment Manager (IEM).
 - a. The original sample sheet can be imported and edited or a new sample sheet can be generated.
 - b. Copy and paste the updated or new sample sheet into the Sample Sheet Editor in BaseSpace.
 - c. BaseSpace will validate the sample sheet and display any issues above the sample sheet editor.
- 1.2.4. When the new or revised Sample Sheet is valid, click the Queue Analysis button. BaseSpace will start analyzing the run using the new sample sheet.

NOTE: Only valid sample sheets will be used for reanalysis. If the sample sheet is invalid, the Queue Analysis button will not be available.

- 1.2.5. If **fixing index assignment**, **the Prep Tab** can be used to change indices and regenerate fastq files for samples that have already been sequenced.
 - 1.2.5.1. Proceed to the run with the incorrect index assignments and click the Run Settings button in the navigation task pane.
 - 1.2.5.2. At the bottom of the page click the pool.
 - 1.2.5.3. Click the Plate ID of the plate, then click Edit.
 - 1.2.5.4. Correct the index in the dropdown menu.
 - 1.2.5.5. Navigate to the affected run and select Generate FASTQ Files from the More dropdown menu.
 - 1.2.5.6. BaseSpace will start to regenerate the fastq files with the corrected indices. The new fastq files will be added to the sample list and can be identified by the date.

NOTE: This option <u>cannot</u> be used for runs that are not set up with the Prep tab or where the wrong library prep kit was selected in the Prep tab.

ATTENTION: MSR and BaseSpace will requeue a new sample sheet independent of each other. If a new sample sheet is requeued with MSR, it will not update the information on BaseSpace. If the one reanalysis attempt has already been used and you want to update the run data on BaseSpace, a new sample sheet can be sent to Illumina Technical Support and they will make the changes on BaseSpace. Along with the request, send the Run ID information, which is the name of the folder for that run. The request file is only valid for 7 days.
