It is very important for student supervisors to openly discuss if student employment is contingent upon one of the funding sources below. Remember that changes to financial aid may be made at any time of the year. Funding is allocated on an annual basis and **DOES NOT** automatically carry over--confirm funding each year.

## FEDERAL WORK STUDY (FWS) FUNDING:

- **FWS** allocations are determined each academic year and ARE visible in SES.
- **FWS** subsidizes 60% of the hourly wage (up to the allocated dollar amount).

- Commitment funding is NOT visible in SES.
- The Commitment office will subsidize 60% of the student wage for Tradition and CPRS Fellows in cases where their student does not have (or runs out of) FWS funding.
- The student must go to the Commitment office EACH YEAR to get the paperwork and give it to his/her supervisor as soon as these funds are needed.

- OADI funding is NOT visible in SES.
- OADI may subsidize between 20% 40% of the student wage. For students with FWS, which pays 60% of the hourly wage, this could mean that 80% 100% of the wage is subsidized.
- The Office of Academic Diversity Initiatives will determine student eligibility and will require contracts to be signed by the employer. This should be done as soon as OADI funds are needed.

## INTERNATIONAL STUDENTS & SCHOLARS FOREIGN STUDENT EMPLOYMENT PROGRAM:

- ISSO Foreign Student Employment funding is NOT visible in SES.
- This is handled as a reimbursement and will require communication with ISSO.
- A *very small number* of international students are eligible for this funding; the average is 50 students per year. International students will be told they have this funding and be given a form to present to their employer. To check, student supervisors can ask international students if they have an "employment component to their financial aid package."
- The form will indicate the maximum amount that has been approved for the year. ISSO will subsidize 60% of the student hourly wage (up to 60% of the maximum approved amount.) Example: if the approved earnings are \$1800 and the student earns \$2200 throughout the year, 60% of \$1800 may be reimbursed to the department. Earnings that exceed the approved \$1800 will be paid out of departmental funds.
