


Summary for 4 years of CLIQ!

- Begun Fall 2015 as a pilot
- 7-question survey (multiple choice and open text)
- Total courses reached in 4 years = 67
 - Fall 2016 highest distribution (23 courses)
 - Spring 2017 lowest distribution (10 courses)
- 1000 level courses are the best represented (58%)
- 3000 level courses are the least represented (<6%)
- By College
 - A&S reaches mostly 1000 level courses
 - CALS reaches mostly 1000 level courses
 - HA reaches mostly 1000 level courses
 - HE reaches mostly upper level courses (3000 / 4000+)
 - ILR reaches mostly 2000 level courses


Total Unique Courses by Semester




Total Courses and Course Sessions per Level



Total number of **Students** by Level




Distribution of courses by College (4 semesters)

How to Search

Library use and Resources/ databases available

- Learned how to find a TON of new resources and how to be able to access different databases (JSTOR, etc.) through the website provided. I also learned that books can easily be borrowed from other universities if they aren't present at Cornell.


• Database Awareness use/Search

- Sifting through which databases are more relevant to my research.


Research Process




One thing they will do differently.....

- I will definitely start with researching some cases and plug that into the database to narrow my framework.
- I'll use the Cornell Library website/ ask librarians for help to make my research more effective
- refine my searches more / use quotes around phrases
- I will use the Boolean search techniques with parenthesis, quotations etc. that I don't usually use in order to specify my search more.
- My research will be more organized by having access to this guide.
- The way I will conduct my research will be different. For example, I will start with an encyclopedia and then narrow my search with articles and primary sources.
- I will use quotes (" ") to have more specific searches
- I will definitely spend less time parsing through results that are irrelevant to my research question, which will also help me gauge what kind of literature is out there on my research question. This will help me refine my paper and ideas.


6. YES, helpful because....
