## **Acquisitions of Special Collections policy for Cornell (**Anne Sauer)

Cornell does not currently have a policy governing the acquisition of special collections. Last fall, Yale shared their policy in this area at the Ivy Plus Collections meeting, and Oya shared this policy with LEG as a possible direction for CUL. LEG is interested in having a similar policy here. Anne passed out Yale's as an example.

Other collection development policies are on the Collection development manual Libguide. See guides.library.cornell.edu/cdmanual and http://guides.library.cornell.edu/cdpolicies.

Anne has met with her counterparts at Ivies Plus meetings to discuss.

Having such a policy at CUL would provide guidance and clarity for librarians, who often find themselves being offered unique or rare materials, without necessarily being aware of all of the complexities that need to be considered before deciding to take in this kind of collection and where such materials are most appropriately housed and managed. A policy would clarify the process for making acquisition decisions, including review by designated special collections units at CUL. This process will ensure that factors such as provenance, ownership, intellectual property, confidentiality/privacy, preservation and other factors are taken into account. Anne will propose a draft policy, consulting with other special collections as well as Kizer, and report back.

#### Mission Essential Functions with Ezra

What to identify as library essential functions in the event of a power failure, emergency, etc. Memo from Feb 22, 2018

We looked at the list of 8 items and discussed the wording. We discussed how the library should provide support for physical resources, electronic resources, and born-digital items which CUL owns. Michelle Eastman, Jon Ladley, and Ezra are working on this. Will distribute to the unit libraries for their input.

#### Curtis

- The American Bar Association Section of Legal Education and Admissions to the Bar which accredits law schools will be sending a site team to the law school in April, the library is part of the site inspection which occurs every 7 years.
- The law library is partnering in a new Research4Life program, GOALI (Global Online Access to Legal Information) which launched at the ILO in Geneva in March.

- Amanda Kiesl is the new Visual Resources Cataloger in RMC, and will start April 1.
- The crystal ball from Wizard of Oz will come here in Mid-April to join the Witchcraft exhibition. It will be on loan from donors and here through reunion.

#### Bonna

- Sat (March 10) CUL and the Johnson Museum hosted the again-successful Wikipedia Art+Feminism Edit-a-thon for the 4<sup>th</sup> year of the event. The group is already planning for next year.
- Olin front entrance work: work will begin immediately following commencement, and will include the entire front entry area, including the outside approach. The project includes replacing the doors, adding a glycol/snow-melt system under the stone paver area, and various other upgrades. The temporary entrance, on the north (Arts Quad) side of the building, will be installed during April in preparation.
- We hope to replace the Annex inventory management system this summer; two firms presented options and negotiations are underway.
- Following up on last month's discussion of a policy for patron-initiated exhibitions, several stakeholders met to discussion, resulting in questions about where this fits on our list of priorities. Mary shared Mann's policy as well. Stay tuned.
